BUILDING CONNECTIONS--IN 2018, THE PARTNERSHIP CONTINUED TO PROVIDE INTENSIVE AND TRADITIONAL MENTORING WITH YOUTH IN THE JUVENILE JUSTICE SYSTEM THROUGH A CONTRACT WITH THE CONNECTICUT JUDICIAL BRANCH, COURT SUPPORT SERVICES DIVISION AND PROVIDED CONTINUED SUPPORT AND TECHNICAL ASSISTANCE TO ENSURE EFFECTIVE PROGRAM PRACTICES AND OUTCOMES TO 150 MENTORING PROGRAMS SERVING OVER 10,000 YOUNG PEOPLE IN THE STATE.
